Furthermore, we (I) (and on behalf of my child-participant if under 21 years of age) hereby assume all risk of person injury, sickness, death, damage, and expense as a result of participation in recreation involved therein. Further authorization and permission is hereby given to said church to furnish any necessary transportation and food for this participant.

The undersigned further hereby agree to hold harmless and indemnify said church, its directors, employees and agents, for any liability sustained by said church as the result of the negligent, willful or intentional acts of said participant, including expenses incurred attendant thereto.

We (I) are the parent(s) or legal guardian(s) of this child, and hereby grant permission for him (her) to participate fully in said trip, and hereby give permission to take said participant to a doctor or hospital and hereby authorize medical treatment, including but not in limitation to emergency surgery or medical treatment, and assume the responsibility of all medical bills, if any.
